RIVERSIDE CITY COUNCIL MEETING; March 20, 2017

The Riverside City Council meeting opened at 6:32 pm in City Hall with Mayor Allen Schneider requesting roll call. Council members present were: Bob Schneider Jr., Jeanine Redlinger, Tom Sexton, Rob Weber, and Ralph Schnoebelen.

Motion by Schneider to approve agenda with the addition of Resolution # 032017-04 WCRF grant for RACC. Second by Redlinger, passed 5-0.

Sexton moved to approve minutes from March 6th and 13th, the expenditures, pulling an MMS and United Lab invoice for clarification, and Schnoebelen Inc. invoice for separate vote. Second by Schneider, passed 5-0. Sexton moved to pay Schnoebelen Inc. invoice. Second by Schneider, passed 4-0 Schnoebelen abstained.

Citizens Comments: Council received a letter from Gary Duder about water bill. Item will be placed on next agenda for Council action.

Cleaning the ditch on 114th Street was tabled for more information.

Quilt Block installation was tabled for installation quote from Murphy's.

Chad Sands from ECICOG was in attendance to answer Council's questions on Building Permit Fees. Sexton moved to have the new schedule on the 4-3-17 agenda for approval. Second by Schnoebelen, passed 5-0.

Jeff Huber of Greiner Buildings presented the final Concept Drawings for the new Hall Park shelter.

Bill Stuke of PeopleService Inc. presented the monthly water and wastewater report.

Sexton moved to proceed with regular wood pole street lighting on Cherry Lane. Second by Redlinger, passed 5-0. Alliant Energy will place a light in the middle and on the west end, with buried service, on the north side of the street.

Sexton moved to list used trucks and old equipment for sale on the Clerk websites, and newspaper, with bids being accepted until 4 pm on April 25, 2017. Second by Redlinger, passed 5-0.

Sexton moved to approve City Grant to the WCRF for Downtown Street Scape in the amount of \$850,000. Second by Schnoebelen, passed 5-0.

Redlinger moved to have Lenz set the specs for a new mower, get sealed bids, sample mowers, and report back to council for a recommended purchase. Second by Weber, passed 5-0.

Mayor Schneider read a City Proclamation for Junior Achievement Day on Thursday, April 6, 2017.

Redlinger presented a letter for Council approval to the Regional Planning Commission on the disbursement of STP funds. Final letter will be signed at next Council Meeting.

Resolution #032017-02 FY 16-17 Audit Service was tabled for cost estimate.

Schneider moved to pass Resolution #302017-03 Appointing People's Trust and Savings Bank and Hills Bank and Trust Co. as City Depositories. Second by Weber, passed 5-0.

Council held discussion on Agenda Preparation. Packet cut-off remains at noon on Wednesday, and packets will be ready on Thursday the week prior to meeting.

Schnoebelen moved to pass Resolution #032017-04 approving WCRF grant for RACC statue in a City Park. Second by Sexton, passed 5-0.

Council Comments: Schnoebelen stated that the ISO Fire Rating has been reduced from 5 to 4. The rating may lower resident's home insurance. Fire Dept. Pancake Breakfast is set for April 9th, 6:30 am – Noon.

Weber has received complaints about dog waste on the ball fields. This is an on-going problem at all City properties. Reminders will be sent out in water bills. Mayor suggested a Dog Park as a project for the Visioning Committee.


Redlinger discussed the problem of duplicate house numbers on City Streets.

Sexton moved to adjourn at 9:50 pm. Second by Weber, passed 5-0.



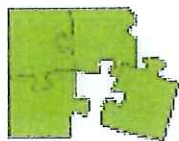
This project will include relocation of the water main along Highway 22 out from under the highway mainline paving, improvements to the raised sidewalks on the north side of Highway 22, ADA improvements along Highway 22 between Glasgow and Greene Streets, and installation of storm sewer to improve drainage within the Highway 22 right-of-way. The project will include decorative retaining walls and decorative lighting on the north side of the highway between Glasgow and Greene Streets, which will make this area ADA compliant as well as enhance the image and revitalize the downtown area. This project is one of several projects over the next three years that aim to improve and beautify the Highway 22 corridor through Riverside.

Highway 22 carries approximately 7100 vehicles per day, according to the IA DOT traffic counts. These Travelers will experience a much improved roadway, and the downtown beautification included with this project will appeal to those travelers so they will stop at the local businesses instead of just passing through. There are 23 commercial buildings located on our downtown area that will also benefit from the revitalization. With the downtown projects, we hope to attract new businesses, grow our population, and improve the quality of daily life for our current residences.

Riverside is committed to community development, projects that improve the quality of life for our citizens, attract more people, revitalize our neighborhoods & downtown & enhance the appearance of our City. Highway 22 is a main thoroughfare for travelers from several other communities to get to 218, so this will benefit many more people than just the citizens of Riverside. NOTE: This is Phase #2 of a multiphase project to revitalize the entire area along Highway 22 through Riverside. The City awarded the contract for Phase #1 to Dave Schmitt Construction in the amount of \$1,322,934.63.

I am writing this letter on behalf of the City of Riverside, Iowa in regards to an application for the Transportation Alternatives Program (TAP). The City of Riverside has identified a project to provide a sidewalk/trail for the students at Highland Community School District to walk from the majority of the City of Riverside to Riverside Elementary School. This school location is the only school building in the community and is the congregational point for all students.

The City of Riverside intends to reconstruct Ella Street this summer from Highway 22 northerly four blocks to the intersection of Blackberry Avenue and Ash Street. An 8' sidewalk/trail on the east side of Ella Street is part of the Ella Street Project.

The TAP funds will allow the City of Riverside to complete the sidewalk/trail system from Highway 22 northerly and easterly to the Riverside Elementary School. Additionally, the City of Riverside intends to construct a new "Community Center" directly west of the Riverside Elementary School as illustrated on the attached exhibit.

The sidewalk/trail will be constructed of Portland Cement Concrete and will be located on the east side of Ash Street/Tupelo Blvd and thence east through the property owned by the City of Riverside, Iowa intended for the "Community Center" and ending at the Riverside Elementary School.

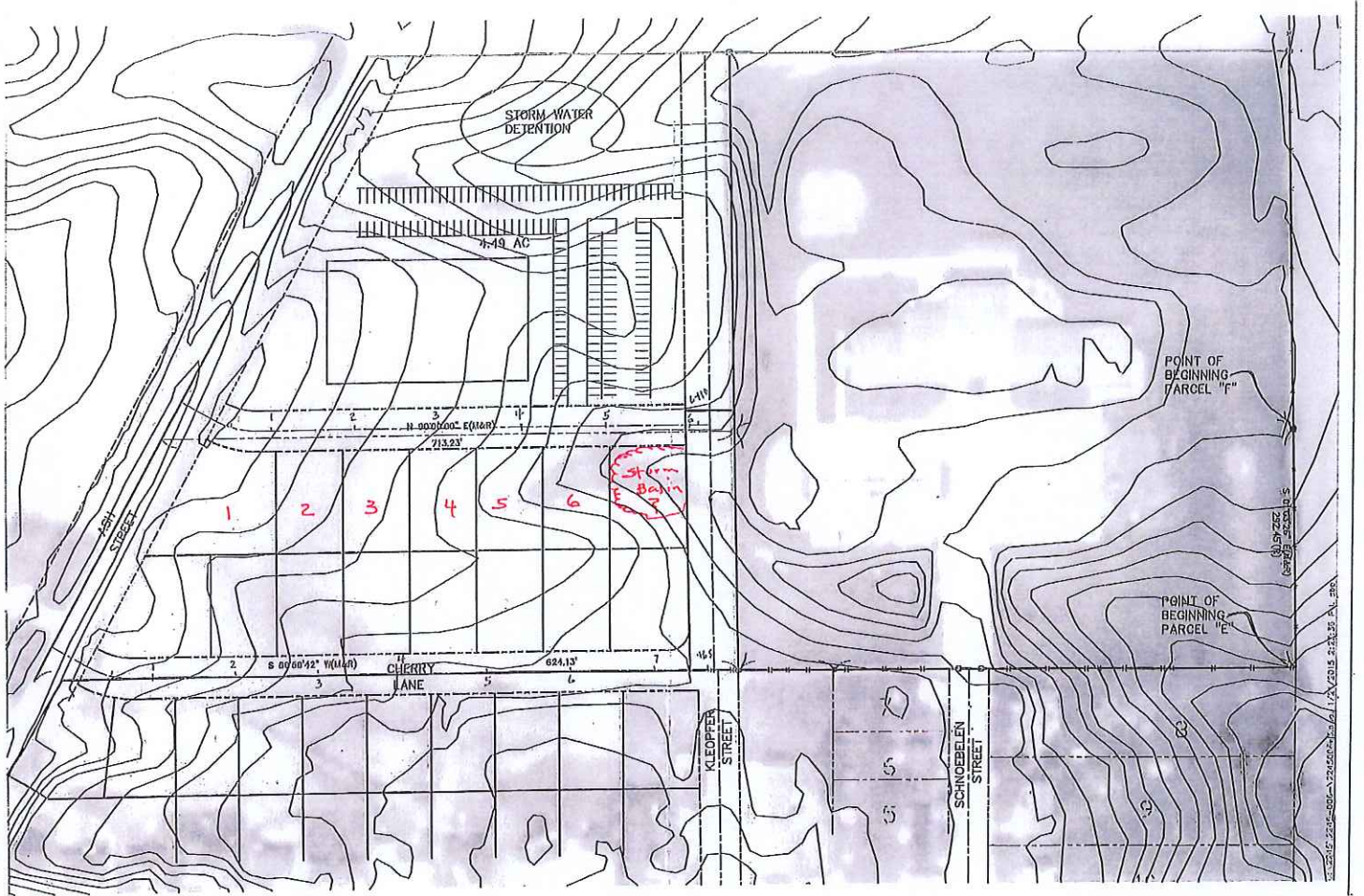

Hi Lory,

I've attached the updated Fee Schedule with the changes discussed last night.

Here is the list of those changes:

- 1) For all valuations (new home, multi-family and business), I deleted \$50,000 or less and made it \$100,000 or less
- 2) For new home permit fee, the totals were lowered between 25% and 50%
- 3) For addition to home, the \$1.00 per each additional square feet was lowered to \$.50
- 4) Added new multi-family valuation and addition to multi-family data
- 5) Used fees for new home for multi-family permit fee
- 6) For new business permit fee, the totals were lowered by about 50%
- 7) For addition to business, the \$1.00 per each additional square feet was lowered to \$.50
- 8) The permit fee for all new garages, regardless of size, was dropped to a flat fee of \$250
- 9) For addition to any garage, the \$1.00 per each additional square feet was lowered to \$.25
- 10) The fee for a pre-application conference was deleted

I would recommend keeping track of all costs associated with building permit applications so you can see how the fees stack up. I suspect they will be quite short of the city's actual costs.

Dear Mr. Hinson,

As you know, STP (Surface Transportation Program) is part of the Federal Highway Administration's funding source to help local communities pay for public transit capital projects, roadway or trail projects. In Iowa the money is divided between 18 Regional Planning Districts in the state with cities over 5000 in population getting their own share of the funds.

One year ago Riverside requested financial aid from Washington County to help with our Hwy 22 project through town. Our request to use \$240,000 of our regional STP funds meets every requirement for STP funding. The roadway in question is not just for Riverside residents' use. It is a highway that is traveled by more than 4,000 vehicles a day from the east, and 7,000 more vehicles on the west where it connects to Interstate 218: *The Avenue of the Saints*. These vehicles include county residents who use it to go to and from work, school busses, agricultural equipment, commercial vehicles from all over the nation, emergency vehicles and tourists. This highway is economically vital to the whole region. Washington County has spent around \$350,000 (STP funds) in *each* of the recent years as part of their current 4-year transportation plan. Riverside's request was for \$240,000 out of the next 4-year plan. Washington County Supervisors based their refusal on the fact that Riverside has generous casino funds to work with. This argument then, should apply to all cities in the county as we all receive casino money, BUT that should not mean that we do not get fair access to a federal program paid for with our tax dollars - especially to help pay for a project that benefits so many in southeast Iowa. This project will require replacing and restructuring numerous infrastructure fixtures under and along this highway, preparing all connecting side streets and even re-doing our downtown area that is dissected by Hwy 22.

We are requesting that our Regional Planning Agency reconsiders how STP funds are distributed: We are not faulting Washington County Supervisors for having other projects to pay for, but after contacting the other 17 Regional Planning Agencies across the state (two of these cover only urban areas) we have found that our region is one of only two that do not make the funds available to all *cities* within their boundaries to ensure that the STP funds are distributed over time to all communities in need. Only Regions 10 and 11 give the funds straight to the counties to be used based upon their supervisors' discretion *alone*.

We believe that a better process for distributing STP funds, one similar to that used by other planning regions, or counties, should be developed so that small communities like ours in Region 10 have a fair method for getting access to their citizens' tax dollars, especially for large projects. The applications used by other Regions are available on-line and would not be difficult to adopt in helping to make sure that these funds are more widely allocated. Please give this your consideration.

Please join us in convincing the Region 10 Planning Agency that a more equitable way exists to distribute STP funds.
