RIVERSIDE CITY COUNCIL MEETING: Tuesday, February 16th, 2021

The Riverside City Council meeting opened at 6:00 pm at the Fire Station with Mayor Allen Schneider requesting roll call. Council members present: Andy Rodgers, Lois Schneider, Tom Sexton, McGuire. Redlinger was absent.

Motion by Schneider to approve agenda. Second by Sexton, passed 4-0.

Rodgers moved to approve the minutes of February 1st and 8th, 2021, expenditures, La Chiva Loka liquor license renewal, and 4 new members to Riverside Volunteer Fire Dept. Second by Sexton, passed 4 -0.

Washington County Sheriff, Jared Schneider presented Law Enforcement Contract for FY22. The department is working to gradually add more deputies to the department. Schneider presented estimated contract law costs through FY26.

McGuire moved to pass Resolution #021621-01, Approving Law Enforcement contract with Washington County for FY22 in the amount of \$131,640.00. Second by Rodgers, passed 4-0.

Highland School Board President Nate Robinson and Superintendent Ken Crawford returned to Council to answer questions on the State of Iowa SF 159 legislature. Crawford provided information from the Iowa Assoc. of School Boards. Mayor Schneider stated the importance of our school district to the City, and suggested that Council members send their own individual letters to our district representatives.

Council reviewed Seal Coat street maintenance estimates.

Sexton moved to pass Resolution #021621-02, Approving seal coat unit prices from LL Pelling of North Liberty, Iowa. Second by Rodgers, passed 4-0.

Bill Stukey, PeopleService, Inc. presented January water and wastewater report.

Scott Pottorff, MMS Consultants discussed engineering options for future Capital Projects. Admin Yancey presented sample RFQ letter with more information to follow.

Sexton moved to enter into closed session per Iowa Code Chapter 21.5 (j) Real Estate at 7:33 pm. Second by McGuire, passed 4-0.

Council returned to open meeting at 7:47 pm.

Sexton moved to proceed as directed in closed session. Second by Rodgers, passed 4-0.

Council reviewed Admin's report, monthly financials, and proposed changes to City Code of Ordinances Chapter 136 – Sidewalk Regulations.

Mayor reported that 23 people completed the Community Center Volunteer Committee Survey. City will move forward with setting the next meeting for this group.

136.01 PURPOSE. The purpose of this chapter is to enhance safe passage by citizens on sidewalks, to place the responsibility for the maintenance, repair, replacement or reconstruction of sidewalks upon the abutting property owner and to minimize the liability of the City.

136.02 DEFINITIONS. For use in this chapter the following terms are defined:

- 1. "Broom finish" means a sidewalk finish that is made by sweeping the sidewalk when it is hardening.
- 2. "Defective sidewalk" means any public sidewalk exhibiting one or more of the following characteristics:
 - A. Vertical separations equal to three-fourths (¾) inch or more.
 - B. Horizontal separations equal to one (1) inch or more.
 - C. Holes or depressions equal to three-fourths (¾) inch or more and at least four (4) inches in diameter.
 - D. Spalling over fifty percent (50%) of a single square of the sidewalk with one or more depressions equal to one-half (½) inch or more.
 - E. Spalling over less than fifty percent (50%) of a single square of the sidewalk with one or more depressions equal to three-fourths (34) inch or more.
 - F. A single square of sidewalk cracked in such a manner that no part thereof has a piece greater than one square foot.
 - G. A sidewalk with any part thereof missing to the full depth.
 - H. A change from the design or construction grade equal to or greater than three-fourths (¾) inch per foot.
- 3. "Established grade" means that grade established by the City for the particular area in which a sidewalk is to be constructed.
- 4. "One-course construction" means that the full thickness of the concrete is placed at one time, using the same mixture throughout.
- 5. "Owner" means the person owning the fee title to property abutting any sidewalk and includes any contract purchaser for purposes of notification required herein. For all other purposes, "owner" includes the lessee, if any.

- 6. "Portland cement" means any type of cement except bituminous cement.
- 7. "Sidewalk" means all permanent public walks in business, residential or suburban areas.
- 8. "Sidewalk improvements" means the construction, reconstruction, repair, replacement or removal, of a public sidewalk and/or the excavating, filling or depositing of material in the public right-of-way in connection therewith.
- 9. "Wood float finish" means a sidewalk finish that is made by smoothing the surface of the sidewalk with a wooden trowel.

136.03 REMOVAL OF SNOW, ICE AND ACCUMULATIONS. It is the responsibility of the abutting property owners to remove snow and ice and accumulations from sidewalks within forty-eight (48) hours. If snow has not been removed within twenty-four (24) hours, an attempt will be made by city staff to contact the property owner. If the contact attempt is unsuccessful, or the sidewalk has not been cleared, a notice will be posted on the door of the address giving 24 hours to remove the accumulated snow from the sidewalk. If sidewalk is not cleared 24 hours after the door posting has been made, the City will contract to have the snow removed and the cost for removal will be billed to the property owner. The property owner has thirty (30) days from the date of the notice to remit payment to the City. Any bills left unpaid will become a lien against the property. This ordinance pertains to residential and commercial property.

Commercial properties located along Highway 22 between Greene and Washburn should have the upper sidewalk portion in front of their abutting property cleared of snow by 8:00 a.m. following the snowfall. The snow may be pushed to the lower sidewalk. City crews will remove the snow from the lower sidewalk and parking. If snow is not removed by 8:00 a.m., it is the responsibility of the property owner to push the snow to the end of the street and not push it onto the cleared lower sidewalk. City staff will be responsible to clearing the stairs.

The eight (8) foot sidewalk located on the east side of Ella Street from 2nd Street to Blackberry will be maintained by the City of Riverside.

(Code of Iowa, Sec. 364.12[2b & e])

136.04 RESPONSIBILITY FOR MAINTENANCE. It is the responsibility of the abutting property owners to repair, replace or reconstruct, or cause to be repaired, replaced or reconstructed, all broken or defective sidewalks and to maintain in a safe and hazard-free condition any sidewalk outside the lot and property lines and inside the curb lines or traveled portion of the public street.

(Code of Iowa, Sec. 364.12 [2c])

136.05 CITY MAY ORDER REPAIRS. If the abutting property owner does not maintain sidewalks as required, the Council may serve notice on such owner, by certified mail, requiring the owner to repair, replace or reconstruct sidewalks within a reasonable time and if such action is not completed within the time stated in the notice, the Council may require the work to be done and assess the costs against the abutting property for collection in the same manner as a property tax.

(Code of Iowa, Sec. 364.12[2d & e])

136.06 SIDEWALK CONSTRUCTION ORDERED. The Council may order the construction of permanent sidewalks upon any street or court in the City and may specially assess the cost of such improvement to abutting property owners in accordance with the provisions of Chapter 384 of the Code of Iowa.

(Code of Iowa, Sec. 384.38)

- 136.07 COMPLIANCE WITH CITY STANDARDS. No person shall remove, reconstruct or install a sidewalk unless such person removes, reconstructs or installs the sidewalk in accordance with the City standards for such work.
- 136.08 SIDEWALK STANDARDS. Sidewalks repaired, replaced or constructed under the provisions of this chapter shall be constructed in accordance with the City's sidewalk specifications on file in the office of the City Clerk.
- 136.09 BARRICADES AND WARNING LIGHTS. Whenever any material of any kind is deposited on any street, avenue, highway, passageway or alley when sidewalk improvements are being made or when any sidewalk is in a dangerous condition, it shall be the duty of all persons having an interest therein, either as the contractor or the owner, agent, or lessee of the property in front of or along which such material may be deposited, or such dangerous condition exists, to put in conspicuous places at each end of such sidewalk and at each end of any pile of material deposited in the street, a sufficient number of approved warning lights or flares, and to keep them lighted during the entire night and to erect sufficient barricades both at night and in the daytime to secure the same. The party or parties using the street for any of the purposes specified in this chapter shall be liable for all injuries or damage to persons or property arising from any wrongful act or negligence of the party or parties, or their agents or employees or for any misuse of the privileges conferred by this chapter or of any failure to comply with provisions hereof.
- 136.10 FAILURE TO REPAIR OR BARRICADE. It is the duty of the owner of the property abutting the sidewalk, or the owner's contractor or agent, to notify the City immediately in the event of failure or inability to make necessary sidewalk improvements or to install or erect necessary barricades as required by this chapter.
- 136.11 INTERFERENCE WITH SIDEWALK IMPROVEMENTS. No person shall knowingly or willfully drive any vehicle upon any portion of any sidewalk or approach thereto while in the process of being improved or upon any portion of any completed sidewalk or approach thereto, or shall remove or destroy any part or all of any sidewalk or approach thereto, or shall remove, destroy, mar or deface any sidewalk at any time or destroy, mar, remove or deface any notice provided by this chapter.
- 136.12 AWNINGS. It is unlawful for a person to erect or maintain any awning over any sidewalk unless all parts of the awning are elevated at least eight (8) feet above the surface of the sidewalk and the roof or covering is made of duck, canvas or other suitable material supported by iron frames or brackets securely fastened to the building, without any posts or other device that will obstruct the sidewalk or hinder or interfere with the free passage of pedestrians.
- 136.13 ENCROACHING STEPS. It is unlawful for a person to erect or maintain any stairs or steps to any building upon any part of any sidewalk without permission by resolution of the Council.

136.14 OPENINGS AND ENCLOSURES. It is unlawful for a person to:

- 1. Stairs and Railings. Construct or build a stairway or passageway to any cellar or basement by occupying any part of the sidewalk, or to enclose any portion of a sidewalk with a railing without permission by resolution of the Council.
- 2. Openings. Keep open any cellar door, grating or cover to any vault on any sidewalk except while in actual use with adequate guards to protect the public.
- 3. Protect Openings. Neglect to properly protect or barricade all openings on or within six (6) feet of any sidewalk.

- 136.15 FIRES OR FUELS ON SIDEWALKS. It is unlawful for a person to make a fire of any kind on any sidewalk or to place or allow any fuel to remain upon any sidewalk.
- 136.16 **DEFACING.** It is unlawful for a person to scatter or place any paste, paint or writing on any sidewalk.

(Code of Iowa, Sec. 716.1)

136.17 **DEBRIS ON SIDEWALKS.** It is unlawful for a person to throw or deposit on any sidewalk any glass, nails, glass bottle, tacks, wire, cans, trash, garbage, rubbish, litter, offal, or any other debris, or any substance likely to injure any person, animal or vehicle.

(Code of Iowa, Sec. 364.12 [2])

- 136.18 MERCHANDISE DISPLAY. It is unlawful for a person to place upon or above any sidewalk, any goods or merchandise for sale or for display in such a manner as to interfere with the free and uninterrupted passage of pedestrians on the sidewalk; in no case shall more than three (3) feet of the sidewalk next to the building be occupied for such purposes.
- 136.19 SALES STANDS. It is unlawful for a person to erect or keep any vending machine or stand for the sale of fruit, vegetables or other substances or commodities on any sidewalk without first obtaining a written permit from the Council.

The City of Riverside is seeking Requests for Qualifications from selected engineering forms for general municipal and project engineering services. The selected firm will be responsible for day-to-day engineering needs that will include but not limited to general civil, water and wastewater and land development with fieldwork, and other duties. Major projects may still be bid out to qualified engineering firms, including the firm selected in this process.

Riverside is a city of approximately 1,000 residents. The City currently operates a ground water source water plant with two city wells, with a reverse osmosis treatment system, built in 2007. The wastewater system consists of five lift stations that flow into an SBR activated sludge plant with UV disinfection built in 2006. The City has been actively engaged in replacing all 4" water mains, upgrading storm water utilities as well as new concrete streets with curb and gutter.

Current projects for FY22 may include adding a soft fall surface with increased handicap accessibility, parking, sidewalks and equipment to Railroad Park; installation of 6" water main on Third Street from Hwy 22 to Washington; and street, curb, gutter, storm sewer and sidewalks from Hwy 22 to Greene Street.

The City is seeking a long-term arrangement with the selected firm, with the firm assigning a primary (City Engineer) and a secondary (Associate City Engineer) contact person to work with the City on an ongoing basis in a prompt and efficient manner. While it is expected that the selected firm will employ several engineers with a wide variety of specializations and utilize them to varying degrees based on the City's needs, the consulting firms City Engineer and/or Associate City Engineer will be the typical points of contact for the City.

The request for qualifications should include but not be limited to:

- Name of firm, address, telephone number, email address.
- Years in business, and office closest to the City of Riverside if more than one office.
- Experience working with a municipality that includes:
 - > ADA projects with extreme terrains
 - Roadway design to direct storm water
- Construction plan preparation and project oversight.

- A comprehensive approach to the proposed work and detailed schedule showing completion.
- Summary of firm's ability to provide personnel to meet the proposed schedule.
- Estimated fee structure and schedule anticipated to accomplish the proposed projects.

• Experience with State and Federal grants, strong experience working with IDOT and DNR regulations and programs.

The selection of firms to interview by Council will be based on:

- Qualifications of firm and personnel assigned to the project.
- Ability of firm to meet full range of City's on-going engineering needs.
- Reference checks on past projects included with submittal.
- · Design approach.
- Experience working with municipalities.
- Project Management style including construction oversight.
- Project Schedule

The City is open to negotiating a per-hour payment arrangement for day-to-day work performed, as well as a negotiated formal contract for larger projects. The City reserves the right to request in-person interviews with the staff to be assigned by the firm prior to making an award of contract. It is expected that the selected firm would begin serving the City of Riverside in the capacity described in this Request for Proposals no later than May 1, 2021.
