

RIVERSIDE CITY COUNCIL MEETING: Monday, June 7th, 2021

The Riverside City Council meeting opened at 6:00 pm at the Fire Station with Mayor Allen Schneider requesting roll call. Council members present: Andy Rodgers, Lois Schneider, Tom Sexton, and Edgar McGuire.

Motion by Rodgers to approve agenda. Second by Sexton, passed 4-0.

McGuire moved to approve Consent agenda.

Minutes of May 17th, 2021, and expenditures.

Liquor License for Kum & Go, Casey's #2629, Copper Creek, and Riverside Casino.

Beer Permit for RACC – TrekFest XXXVI

Tobacco Permits for Casey's #3900, Casey's #2629, Kum & Go #0080, Riverside Casino, and Dollar General #21630.

Second by Schneider, passed 4-0.

Chris Kirkwood requested that Council consider adding a fall clean-up day

Sexton moved to accept the resignation of Jeanine Redlinger as of May 31, 2021. Second by McGuire, passed 4-0. Mayor Schneider presented Redlinger with an Award of Gratitude with thanks and appreciation for serving 5 ½ years on the City Council of Riverside.

Rodgers moved to grant partial sewer abatement for Danae Besch, \$10.20 and Rodger Brand, \$29.10 for filling of swimming pool. Second by McGuire, passed 4-0.

Committee members Annie Nugent, Trish Woepking, and Kate Giannini addressed Council with progress from Community Center meetings. Tad Morrow, with Carl A Nelson, was available to answer questions.

Rodgers moved to purchase a SAM Aspirator Replacement pump from Iowa Pump at cost of \$8789, plus freight. Second by Schneider, passed 4-0.

McGuire moved to pass Resolution #060721-01, Hiring audit firm of Gronewold, Bell, Kyhmm & Co. for audit services for Fiscal Year ending June 30, 2021. Second by Schneider, passed 4-0.

McGuire moved to pass Resolution #060721-02, Approving the Maintenance and Repair of Primary Roads Agreement with Iowa DOT. Second by Sexton, passed 4-0.

Rodgers moved to pass Resolution #060721-03, Approving Contract with PeopleService, Inc. for operation and maintenance of City of Riverside's water and wastewater plants. Second by Sexton, passed 4-0.

Sexton moved to approve street closings for Trek Fest, June 25th and 26th. Second by Schneider, passed 4-0.

Rodgers moved to publish Notice of Intent to fill Vacancy by Appointment. Second by Sexton, passed 4-0. Notice will be in this week's paper and on City website.

Sexton moved to return City Council Meetings to City Hall with the next June 21st meeting. Second by Rodgers, passed 4-0.

Admin Yancey presented Administrator's report, American Rescue Funding, removal of State backfill funding, and removal of mask requirement.

Sexton moved to adjourn at 7:37 pm. Second by McGuire, passed 4-0.


