RIVERSIDE CITY COUNCIL MEETING: Monday, July 19th, 2021

The Riverside City Council meeting opened at 6:00 pm at City Hall with Mayor Allen Schneider requesting roll call. Council members present: Andy Rodgers, Lois Schneider, Tom Sexton, Edgar McGuire, and Kevin Mills.

Motion by Sexton to approve agenda. Second by Rodgers, passed 5-0.

Schneider moved to approve the minutes of July 6th, 2021, expenditures, and June Fire Department Report. Second by Rodgers, passed 5 -0.

Chris Kirkwood asked Council about fall City Wide Clean-up.

Sandie Ubben reported on Sunday's Classy Chasse Car Show at Hall Park. All proceeds from food sales will be donated to U of I Children's Hospital.

Washington County Sheriff's deputy was unable to attend meeting.

Bill Stukey, PeopleService, Inc. reviewed June water and wastewater report with Council.

Council discussed 3% pay increase for City workers, as recommended by Employee Committee. McGuire moved to pass Resolution #071921-01, Approving 3% pay increase. Motion died due to lack of second.

Rodgers moved to approve pay increase of 2%. Second by Mills, passed 3-2. McGuire and Sexton voting no.

Nick Bettis, Axiom Consultants was in attendance to answer Council questions on Engineering Services.

McGuire moved to pass Resolution #071921-02, Approving professional services agreement for Engineer Master Services, and On-Call Engineering, with Axiom Consultants. Second by Schneider, passed 5-0.

Schneider moved to approve four Residential Grant Request for \$2500 each to Bill Poch, Travis Riggan, Morgan Rodgers, and Jessica Miller. Second by Sexton, passed 4-0. Rodgers abstained.

Schneider moved to approve one Commercial Grant Request for \$5593 to John Sojka. Second by Sexton, passed 5-0.

Sexton moved to approve \$25.08 sewer abatement request for filling swimming pool at 220 Buckeye Lane. Second by Rodgers, passed 5-0.

Council will table sidewalk bids till next meeting.

Yancey presented Admin's report and monthly financial updates.

Sexton moved to enter into Closed Session per Iowa Code Chapter 21.5 (1) (i) Employee review at 8:06pm. Second by Rodgers, passed 5-0.

RESOLUTION CALLING FOR A PUBLIC REFERENDUM TO AUTHORIZE THE IMPOSITION OF A LOCAL OPTION SALES AND SERVICE TAX IN THE CITY OF RIVERSIDE, WASHINGTON COUNTY, IOWA, AT A RATE OF ONE PERCENT (1%) EFFECTIVE JULY 1, 2022 THROUGH JUNE 30, 2032

WHEREAS, Chapter 423B of the code of Iowa authorizes the imposition of certain local option taxes after an election in which the majority of the electors vote in the affirmative; and

WHEREAS, the Riverside City Council declares its intent to permit the City of Riverside electorate to pass upon the proposition of imposing a one percent (1%) sales and service tax for the City of Riverside according to Chapter 423B of the 2001 Code of Iowa on the regular city election date of November 2, 2021.

THEREFORE BE IT RESOLVED, by the City Council of the City of Riverside, Iowa as follows:

SECTION 1. The City Council of Riverside, Iowa, requests the County Commissioner of Elections to submit to the voters in the City of Riverside on the regular city election date of November 2, 2021, the following proposition authorizing imposition of a one percent (1%) local sales and service tax in the City of Riverside effective July 1, 2022 through June 30, 2032.

SECTION 2. The revenues from the local option sales and service tax are to be allocated in the City of Riverside as follows:

40% of said local option sales and service tax to be allocated for property tax relief.

60% of said local option sales and service tax to be allocated for infrastructure improvement and capital projects such as but not limited to community building, city office building, street improvements, water system improvements, sewer system improvements and recreation facilities.

SECTION 3. That the City Clerk is hereby authorized and directed to provide a certified copy of this resolution to the County Commissioner of Elections of Washington County and to the Board of Supervisors of Washington County.

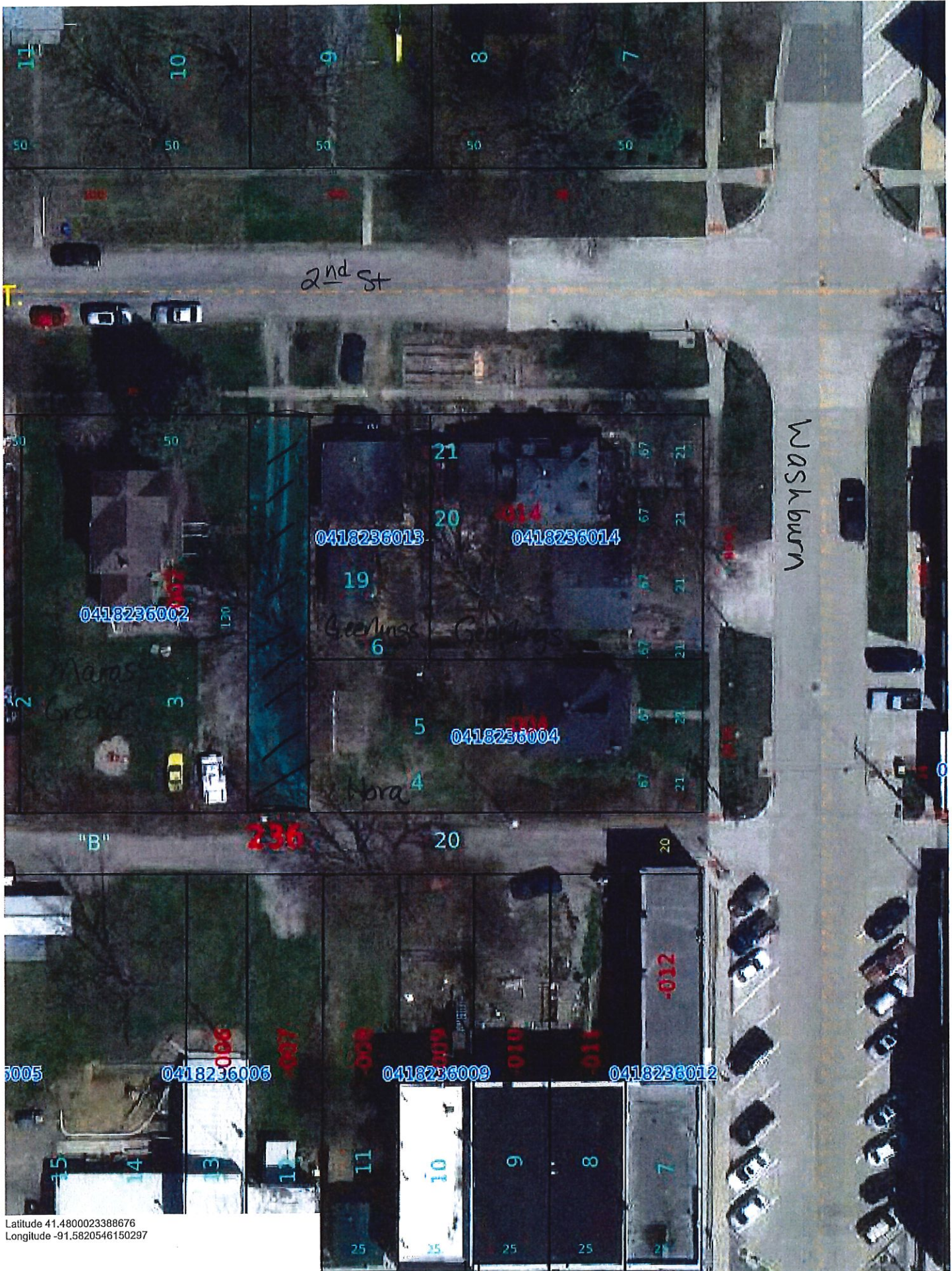

Procedures for vacating an alley:

1. Letter with request from applicant asking for vacation to present to council.
- 8/2 2. Council motions to send request to Planning & Zoning Commission for review and recommendation. The Commission has 30 days from the date of the council request to provide recommendation to council. The Commission meets on the 4th Tuesday of the month. 9/24
- 9/7 3. Following recommendation by Commission, Council, by resolution, sets a public hearing following the 4/20 posting requirement. Legal description must be included in the public hearing notice.
- 9/21 4. Council holds public hearing. Following public hearing, an ordinance is required with three readings, or the second and third readings may be waived. Ordinance needs to be recorded with Washington County.
5. City attorney will prepare the deed to vacate the alley.
6. If approved, Mayor signs the deed returning the alley to private land. Deed needs to be recorded with Washington County.

364.7 Disposal of property.

A city may not dispose of an interest in real property by sale, lease for a term of more than three years, or gift, except in accordance with the following procedure:

1. The council shall set forth its proposal in a resolution and shall publish notice as provided in [section 362.3](#), of the resolution and of a date, time and place of a public hearing on the proposal.

2. After the public hearing, the council may make a final determination on the proposal by resolution.

3. A city may not dispose of real property by gift except to a governmental body for a public purpose.

VACATION AND DISPOSAL OF STREETS

137.01 Power to Vacate
137.02 Planning and Zoning Commission
137.03 Notice of Vacation Hearing

137.01 POWER TO VACATE. When, in the judgment of the Council, it would be in the best interest of the City to vacate a street, alley, portion thereof or any public grounds, the Council may do so by ordinance in accordance with the provisions of this chapter.

(Code of Iowa, Sec. 364.12 [2a])

137.02 PLANNING AND ZONING COMMISSION. Any proposal to vacate a street, alley, portion thereof or any public grounds shall be referred by the Council to the Planning and Zoning Commission for its study and recommendation prior to further consideration by the Council. The Commission shall submit a written report including recommendations to the Council within thirty (30) days after the date the proposed vacation is referred to the Commission.

(Code of Iowa, Sec. 392.1)

137.03 NOTICE OF VACATION HEARING. The Council shall cause to be published a notice of public hearing of the time at which the proposal to vacate shall be considered.

137.04 FINDINGS REQUIRED. No street, alley, portion thereof or any public grounds shall be vacated unless the Council finds that:

1. Public Use. The street, alley, portion thereof or any public ground proposed to be vacated is not needed for the use of the public, and therefore, its maintenance at public expense is no longer justified.
2. Abutting Property. The proposed vacation will not deny owners of property abutting on the street or alley reasonable access to their property.

137.05 DISPOSAL OF VACATED STREETS OR ALLEYS. When in the judgment of the Council it would be in the best interest of the City to dispose of a vacated street or alley, portion thereof or public ground, the Council may do so in accordance with the provisions of Section 364.7, Code of Iowa.

(Code of Iowa, Sec. 364.7)

137.06 DISPOSAL BY GIFT LIMITED. The City may not dispose of real property by gift except to a governmental body for a public purpose or to a fair.
