RIVERSIDE CITY COUNCIL MEETING: Tuesday, January 4, 2022

The Riverside City Council met on Tuesday, January 4, 2022, at the Riverside City Council Chambers. Mayor Allen Schneider called the meeting to order at 7:10 p.m. and following the Pledge of Allegiance requested roll call. Council members present: Tom Sexton, Edgar McGuire, Kevin Kiene, Lois Schneider, and Kevin Mills.

Motion made by Sexton to approve agenda, second by McGuire. Motion passed 5-0.

Motion made by Kiene to approve Consent Agenda, including 12-20-2021 minutes and 1-4-2022 expenditures, second by Schneider. Motion passed 5-0.

Motion made by McGuire, second by Schneider to open Public Hearing for the Sale of Real Estate-Lot #8 Cherry Lane. Roll call. Motion passed 5-0. Hearing opened at 7:16 p.m. There were no questions or comments from the audience or received at city hall. Motion made by Sexton, second by Kiene to close Public Hearing. Roll call. Motion passed 5-0. Hearing closed at 7:17 p.m.

MaryJane Stumpf and Chris Kirkwood presented a request NTE \$500 to pay for an intern to work on the Sesquicentennial Book. The intern will be employed by the City of Kalona. Motion made by Schneider, second by McGuire to approve request NTE \$500. Motion passed 5-0.

Motion made by McGuire, second by Sexton to approve Resolution #20220104-01, sale of Lot #8, Cherry Lane for \$40,000.00 to Bailee and Morgan Samson. Roll call. Motion passed 5-0.

Motion made by McGuire, second by Kiene to approve Resolution #20220104-02, release of retainage to J&L Construction for the final sod project on the 4th Street Construction Project. Roll call. Motion passed 4-1, Mills voting no.

Motion made by McGuire, second by Schneider to approve Resolution #20220104-03, appoint City Attorney William J Sueppel. Roll Call. Motion passed 5-0.

Discussion on the possible waiving of review of Plat for Stumpf Construction Co, LTD located within the two-mile radius of the city limits of Riverside. As there were items needing clarification, no action was taken on Resolution #20220104-04 and the plat will be reviewed by Planning & Zoning and the city council.

City Administrator Yancey gave an overview for council. Yancey had prepared notes on the 3rd Street Project walk through work session held November 23, 2021. Plans will be further reviewed at the budget work session. Yancey asked for review of the Hotel/Motel, Commercial and Residential Grant Applications to determine the objective of each. Applications will be further reviewed at the budget work session, and council will determine the amount of funding allocated for each.

Mills, Schneider, and Kiene provided council comments. Mayor Schneider reminded council of Monday budget work session.

Motion made by McGuire, second by Kiene to adjourn the meeting. Motion carried 5-0. Mayor adjourned the meeting the time being 8:22 p.m.

The members trained on winter fire ground operations.

RESA:

The annual RESA meeting with the board members was set for January 20th. This will provide an update of funds raised and expenses for 2021. The members will also work on new funding ideas and review past goals.

Other News

The members had another steady month responding to various types of calls. We finished the year with a record number of calls for RFD. We will continue to look at how we provide service and coverage for all hours of the day. We had 12 calls that we had no personnel available to respond to in 2021, these were EMS type calls. The Chief is working with Christine on budget items. We will get a date set for the annual RFD report to the council. We looked at a new cardiac monitor for RFD, grant funding was found to purchase this device. I would like to thank DC Hancock for all his hardwork on how we provide EMS to the community. We will move forward with becoming a Paramedic level service with the State of Iowa. This was discussed at the work session, and we have the ability to provide that with our current volunteers. It's foolish to not let our advanced providers to provide that level of care on EMS calls that they can do life saving interventions. I will have an update of all this at the RFD annual report to the council.

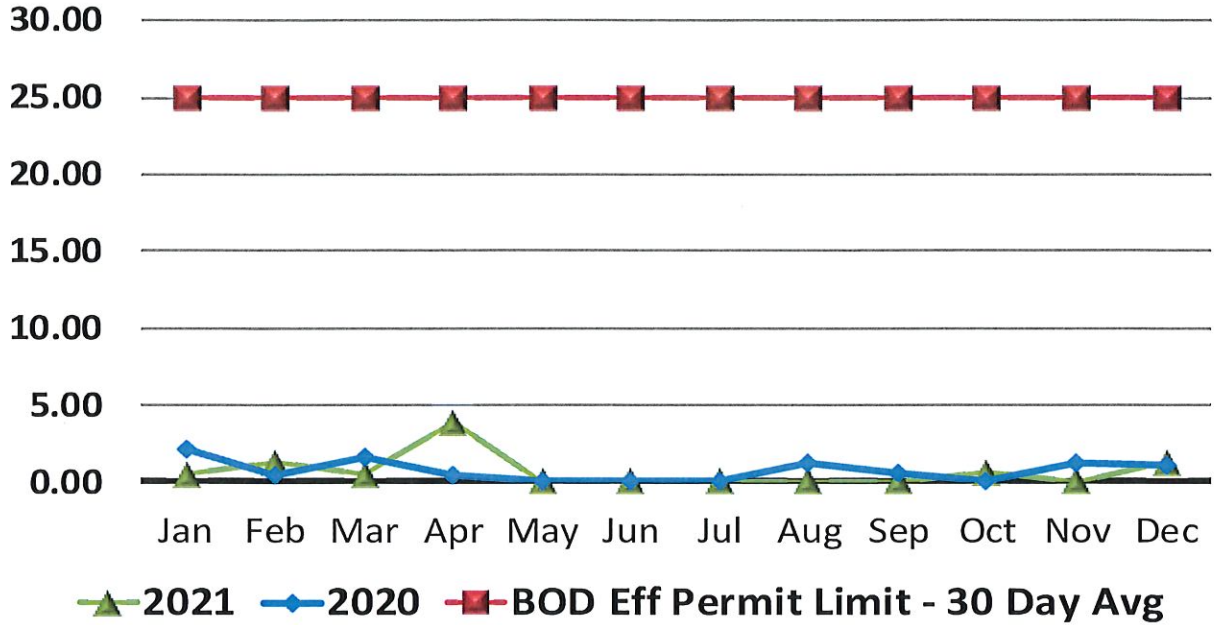
Wastewater Operation & Maintenance

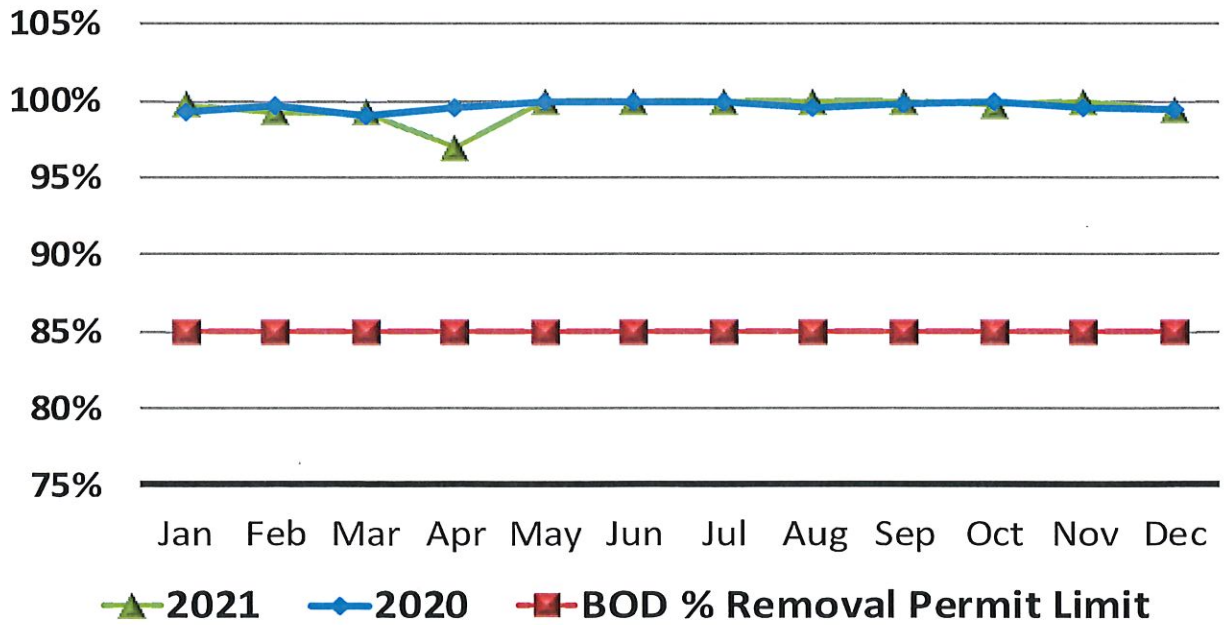

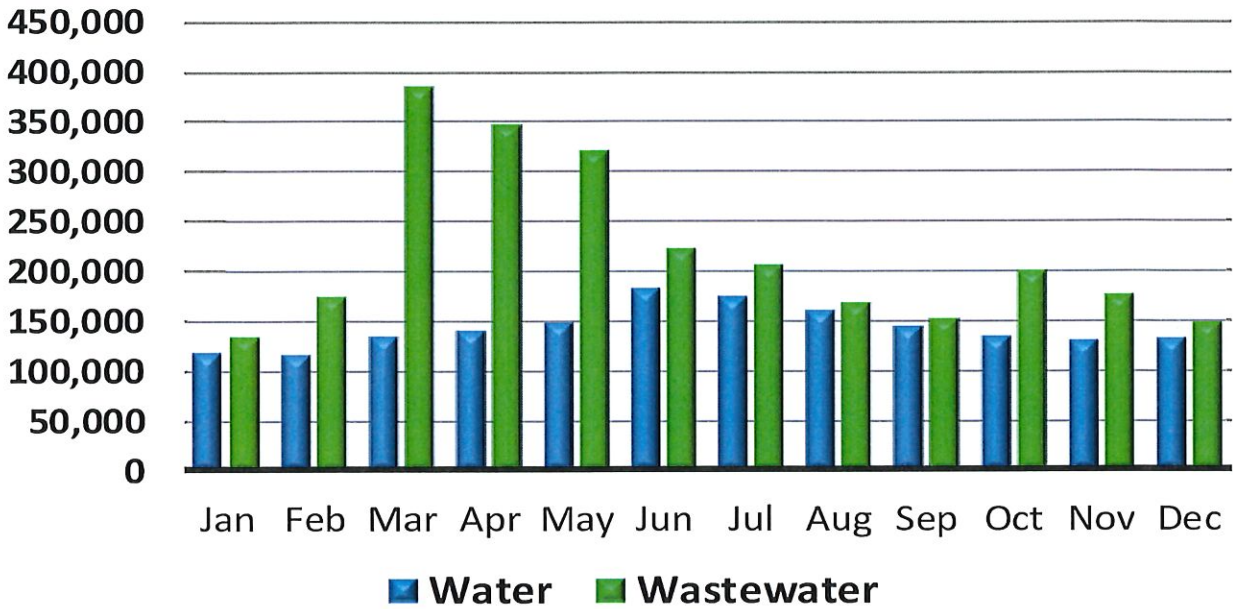
BOD Effluent

Good morning Christine, good to see you last night and glad to have gotten some direction from Council. I completely forgot to bring this up last night at the work session, but we are recommending that we have the existing sanitary sewer along Third Street televised to make sure all is in good condition prior to reconstruction the street and installing new pavement over it. In talking with Bill, sounds like they feel it is in good condition but it has not been televised since 2013. There has also been discussion by council members to replace the laterals (sanitary services) from the main to the City Right-of-Way and if we televise we will be able to document those locations and visually evaluate the services connections as well.

Sounds like PeopleService would have to hire this out and the City would pay for it. They currently have a contract with Visu-Sewer and they are supposed to be televising another line for Riverside soon so we may be able to get it done fairly quick. Do we need to run this by Council or can we give direction to have it taken care of?

My apologies for not bringing this up last night.

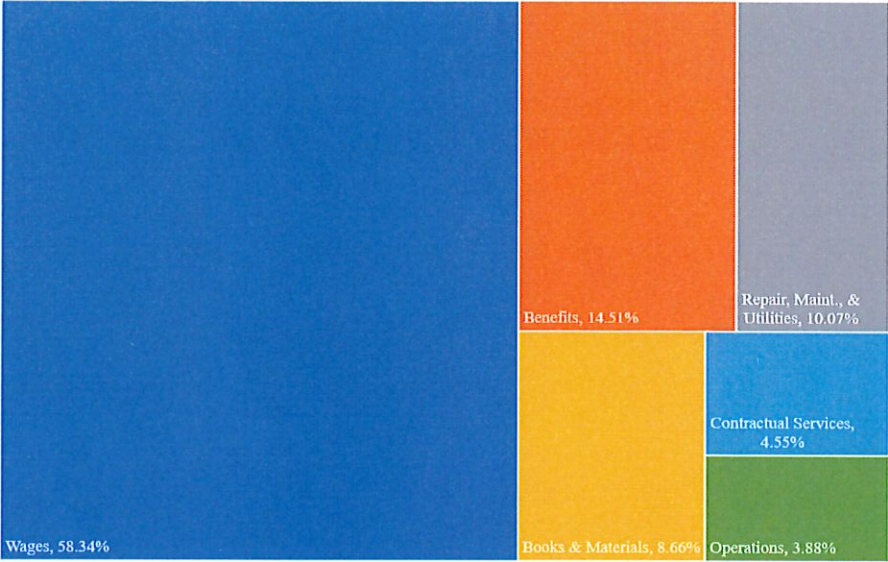
Fines

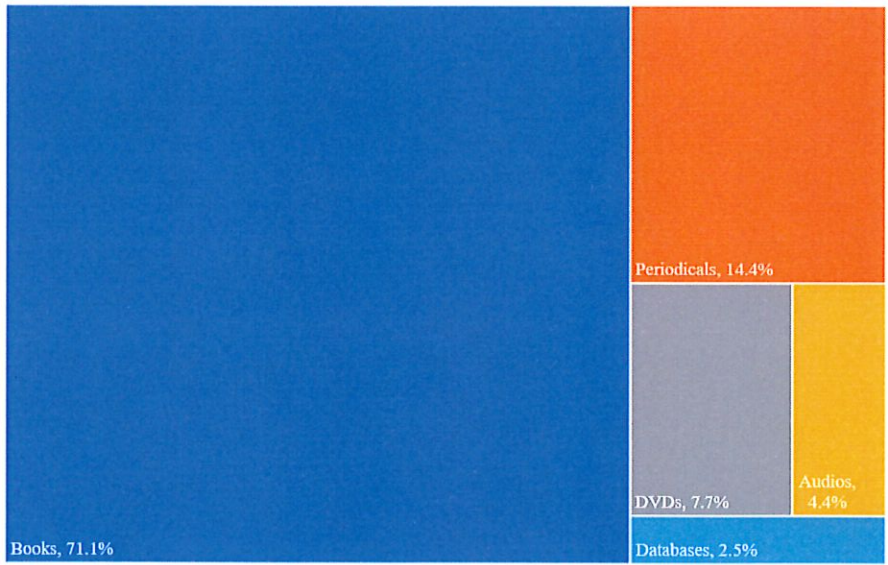
